He has also been a Brazilian advisor before UNCITRAL Working Groups I (micro, small and medium sized enterprises) and V (Insolvency Law) since 2012. Satiro is a founding member of Satiro Advogados Law Firm.

Paula Betancourt, Former Advisor of Superintendence of Companies, Colombia

Paula is a political scientist and lawyer from the Universidad de los Andes and specialist in Commercial Law from the Pontificia Universidad Javeriana.

Until January 2022, she served as Advisor to the Superintendent of Companies for Insolvency issues and as an ad hoc judge. Drain was a partner in the Bankruptcy Department of the New York law firm of Paul, Weiss, Rifkind, Wharton & Garrison, where he represented debtors, trustees, secured and unsecured creditors, official and unofficial creditors' committees, and buyers of distressed businesses and distressed debt in chapter 11 cases, out-of-court restructurings, and bankruptcy-related litigation. He also was actively involved in several transnational insolvency matters.

He is also one of the drafters of the Asian Principles of Business Restructuring as well as the author of the Guide on the Treatment of Insolvent Micro and Small Enterprises in Asia published by the International Insolvency Institute and the Asian Business Law Institute. Aurelio is a member of the Academic Steering Committee of INSOL International as well as a member of the expert panel that advises the Singapore Ministry of Law on matters relating to the insolvency work conducted by the United Nations Commission on International Trade Law (UNCITRAL).
